

ORDINANCE NO. 2009-6

AN ORDINANCE TO AMEND ARTICLE VI, RATES AND CHARGES, SECTION 32-431, SCHEDULE OF SEWER RATES TO PROVIDE FOR AN INCREASE IN SEWER RATES FOR RESIDENTIAL AND COMMERCIAL USERS FOR THREE-FOURTH INCH METERS AND TO FURTHER AMEND SECTION 32-431 TO ESTABLISH MINIMUM SEWER RATES FOR METERS LARGER THAN THREE-FOURTH INCH AND TO ESTABLISH A MAXIMUM CAP AT 15,000 GALLONS.
