CALL TO ORDER

Mayor Rivera called the meeting to order and led in prayer.

PRESENTATION VIA ZOOM BY THE SC REVENUE AND FISCAL AFFAIRS OFFICE

Mr. Adam DeMars and his staff from the SC Revenue and Fiscal Affairs Office (SFA) gave a presentation on redistricting and presented a 2020 redistricting report. Redistricting is the process of redrawing the lines of districts from which public officials are elected. It affects all jurisdictions that have single member elections and takes place after each census. He explained the recommendation and procedures on how the lines should be redrawn. Only federal data from the 2020 census can be used to redraw lines. The population of the City has decreased 2.1%. As a result, the ideal target population in a district changed from 791 to 775. The maximum deviation rate is 10% but SFA recommends 5%. He presented a report that showed the current statistics and a suggested plan that would realign the districts to meet the requirements. He explained that the SFA's role is to provide state and local governments with services performed in accordance with redistricting laws and principles. They are a neutral party. They can present changes to the maps based on Council input.
