### **CALL TO ORDER & PRAYER**

Mayor Pro Tem Kinlaw called the meeting to order. Councilmember Bragg led in prayer.

## **COMMENTS FROM THE MAYOR OR COUNCIL MEMBERS**

Mayor Pro Tem Kinlaw asked if there were any comments from the Council Members. Council Member Alicia Davis said she had a comment. Ms. Davis stated that she was still not satisfied with the map that was voted upon due to the splitting up of a key part of a neighborhood over on Camelia Street. She feels that the map introduced as Draft 6, where the deviation was at 7.87% was a better split of the neighborhoods than Draft 1, where the deviation was at 2.45%. Mayor Pro Temp Kinlaw stated that not only were the numbers lower in Draft 1, but also, in almost every district, you find where the lines are drawn, they split up neighborhoods. It is just the way it happens. She also talked about the time it will take the Election Commission to prepare new cards for those who are changing to a different district. The white portion of the voter registration card has very important information on it about that voter's districts that they reside in. Don't tear off the white portion because of this important information.

There was no further business. A motion was made by Council Member Davis to adjourn and seconded by Council Member Bragg. The meeting was adjourned.
